PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER! CORROSIVE. Causes irreversible eye damage and skin burns. May be fatal if inhaled, swallowed or absorbed through the skin. Do not get in eyes, on skin or on clothing. Do not breathe spray mist (or vapor). Wear a dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C). Wear protective eyewear (goggles or face shield), protective clothing and rubber gloves. Wash thoroughly with soap and water after handling and before eating, drinking, or using tobacco. Remove contaminated clothing and wash clothing before reuse.

FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.
IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.
IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferable by mouth-to-mouth if possible. Call a poison control center or doctor for treatment advice.

Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression, and convulsion may be needed.

DIRECTIONS FOR USE

This product is for formulation into antimicrobial products for use in/on Agricultural premises and equipment, Food Handling/storage establishment premises and equipment, Commercial, institutional and industrial premises and equipment, Residential premises, Medical Premises and equipment, Industrial processes and water systems, Wood preservatives and Swimming Pools. Formulators using this product are responsible for providing data for the EPA registration of their formulated products. This product may be used to formulate products for specific use(s) not listed on this label if the formulator or primary registrant has complied with U. S. EPA data requirements regarding the support of such use(s).

NOTE: This product should not be used or compounded with any reducing or oxidizing agents (such as calcium hypochlorite, solid perchlorate, or nitric acid) since such mixtures may be explosive. Do not use in conjunction with soap or any anionic wetting agent.

STORAGE AND DISPOSAL
