 Update First Aid Statements, Precautionary Statements, Storage and Disposal Statements as required by the applicable PR Notices and the Label Review Manuel.

Conditions

Revise the label as follows:

1. The Agency has completed risk assessments to characterize the chemical, Alkyl Dimethyl Benzyl Ammonium Chloride (ADBAC). During this process, the acute toxicology profile was determined for Manufacturing Use Products (MUP) with an active ingredient concentration ranging from 40% to 80% and End-Use Products (EP) that are formulated repackages of MUPs in the aforementioned concentration range. According to this data, this product is classified as tox. If for acute inhalation, so the "Precautionary Statements" must be revised by adding the following statements:

- 4. Under the "Directions for Use, delete the use sites, "Residential and Public access premise, Antifouling Coating, Materials and Preservatives, Swimming Pools and Aquatic areas. These sites are not supported by this active ingredient.
