The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, will be acceptable provided that you make the labeling changes listed below before you release the product for shipment bearing the amended label.

1. Add the restrictive label statement outlined in PR-Notice 94-4: "This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to pre-clean or decontaminate critical or semi-critical medical devices prior to sterilization or high level disinfection".
2. Change Trichophyton interdigitale to Trichophyton mentagrophytes.

A stamped copy of your labeling is enclosed for your records. Submit one (1) copy of the final printed label prior to release of the product for shipment.

Spray regularly to eliminate most germs from bedsteads, bed springs, bed rails, bedside tables, bathroom basins, toilet seats, shower stalls, bathtubs, telephones, door handles, light switches, plumbing and plumbing fixtures, window blinds, empty hampers, waste receptacles, sills, walls, closets, places where germs may be a problem. The aerosol spray penetrates areas hard to reach with non-propelled liquid disinfectants.

PREVENTS MOLD AND MILDEW.

Use in basements, closets, laundry rooms, summer cottages, boats, storage areas, shower stalls. Excellent for preventing mold and mildew on mattresses, pillows, shower curtains, painted surfaces, tiled walls, curtains and similar surfaces. For mildew control follow directions for disinfection. Application should be repeated once a week or when new growth appears on hard surfaces.

DIRECTIONS

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

(ce should be cleaned prior to application.

TO DISINFECT, hold can upright, 6" to 8" from surface. Spray surface 2 to 3 seconds or until covered with fine mist. Let dry on surface. Avoid spraying lacquered or shellacked surfaces.

TO DEODORIZE, hold can upright and spray into center of room 1 to 2 seconds.

STORAGE: Store in a cool area.

DISPOSAL: Replace cap on empty container and discard in trash.
