The following amendment submitted in connection with registration under section of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) as amended, is acceptable with comments.

Proposed Amendment

 Revisions as per EPA comments letter for P-39 6836-177 dated January 24, 2002.

Label Comments

- 1. Delete the phrase" of Lonza Formulation P-13 per gallon of water or equivalent dilution" under the SALON (BARBER) INSTRUMENTS AND TOOLS DISINFECTION /VIRUCIDE* /DIRECTIONS heading, because it is redundant.
- Qualify the use sites as follows "microwave ovens (exterior); refrigerator (exterior)....."
- 3. Revise the toilet bowl directions for use by adding the statement, " Bush or swab thoroughly, allow to stand for 10 minutes and flush.

Apply the use solution with a clean mop, sponge, cloth, squeegee or mechanical scrubber. For disinfection, thoroughly wet the surfaces to be treated. Surfaces must remain moist for at least 10 minutes to assure proper germicidal action. Wipe dry with a clean cloth or sponge or allow to air dry.
