PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER! CORROSIVE. Causes irreversible eye damage and skin burns. May be fatal if inhaled, swallowed or absorbed through the skin. Do not get in eyes, on skin or on clothing. Do not breathe vapor. FIRST AID

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferable by mouth-to-mouth if possible. Call a poison control center or doctor for treatment advice.

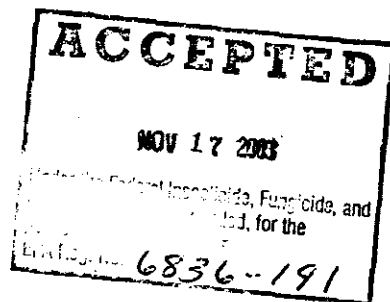
