Contact time:

For HIV-1: Use 2 oz. of Lonza Formulation DC-110N per gallon of water (16 mL per liter). Leave surfaces wet for 2 minutes. For HBV: Use 3 oz. of Lonza Formulation DC-110N per gallon of water (24 mL per liter). Leave surfaces wet for 10 minutes. For disinfection against all other bacteria and fungi claimed: Use a 10-minute contact time

**Disposal of Infectious Materials:** Blood, body fluids, cleaning materials and clothing should be autoclaved and disposed of according to local regulations for infectious waste disposal.

# NON-ACID TOILET BOWL AND URINAL DISINFECTANT / CLEANER DIRECTIONS:

#### From concentrate:

Add 2 - 3 oz. (60 - 90 mL) to the toilet bowl and mix. Brush thoroughly over exposed surfaces and under the rim. Allow to stand for 10 minutes and flush.

#### From use-solution:

Empty toilet bowl or urinal and apply 2 - 3 oz. per gallon (16 - 24 mL per liter) use-solution to exposed surfaces including under the rim with a cloth, mop, sponge or sprayer. Allow to stand for 10 minutes and flush.

#### For Heavy-duty use:

Empty toilet bowl or urinal and apply 8 oz. per gallon (64 mL per liter) use-solution to exposed surfaces, including under the rim with a cloth, mop, sponge or sprayer. Allow to stand for 10 minutes and flush.

#### **GLASS CLEANING / DEODORIZING DIRECTIONS:**

Add 1 - 4 oz. per gallon of water (8 - 32 mL per liter) to clean and deodorize windows, mirrors and glass surfaces.

For sprayer applications, use a coarse spray device. Spray 6 - 8 inches from surface; rub with sponge or cloth. Do not breathe spray.

#### DIRECTIONS FOR FOOD PROCESSING PLANTS:

For use on non-food, contact surfaces such as floors, walls, tables, garbage cans and disposal areas. Follow disinfection directions.

#### DIRECTIONS FOR FOOD STORAGE AREAS:

For use on non-food, contact surfaces such as shelves, floors, walls and tables: Before using this product, food products and packaging materials must be removed from the room or carefully protected. Then follow disinfection directions.

**DIRECTIONS FOR RESTAURANTS, CAFETERIAS, BARS:** Rinse all surfaces which come in contact with food such as countertops, appliances, tables and stovetops with potable water before reuse. Do not use this product to disinfect utensils, glassware and dishes.

### DIRECTIONS FOR SANITIZING NON-FOOD, CONTACT SURFACES:

Add 2 - 3 oz. per gallon of water (16 - 24 mL per liter), to sanitize hard, nonporous, environmental surfaces. Treated surfaces must remain wet for 60 seconds. Wipe dry with a clean cloth or, sponge or allow to air dry.

# POULTRY AND SWINE PREMISE SANITATION SITE PREPARATION:

The first step in any on-going sanitation program should be the removal of gross contamination and debris. This may be accomplished using a shovel, broom, or vacuum depending on the area to be disinfected. The efficacy of even the most efficient germicidal cleaner is reduced in the presence of heavy organic matter. Once the heavy debris is eliminated, disinfection can be accomplished in one easy step.

#### **CLEANING:**

For all general cleaning, use 2 - 3 oz. of LONZA FORMULATION DC-110N per gallon of water. Apply usesolution with a cloth, mop or pressure sprayer so as to thoroughly wet surfaces. Wipe dry with a clean cloth or sponge or allow to air dry.

#### **DISINFECTION:**

Remove all animals and feeds from premises, trucks, coops and crates. Remove all litter, droppings and manure from floors, walls and surfaces of facilities occupied or traversed by animals. Empty all troughs, racks and other feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Use 2 - 3 oz. of LONZA FORMULATION DC-110N per gallon of water. Saturate surfaces with the recommended disinfecting solution for a period of 10 minutes. Immerse all halters, ropes, and other types of equipment used in handling and restraining animals, as well as forks, shovels and scrapers used for removing litter and manure. Wipe dry with a clean cloth or sponge or allow to air dry. Ventilate buildings, coops, and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set or dried. Thoroughly scrub treated feed racks, troughs, automatic feeders, fountains and waterers with soap or detergent, and rinse with potable water before reuse.

HATCHERIES: Use 2 - 3 oz. of LONZA FORMULATION DC-110N per gallon of water to treat hatchers, setters, trays, racks, carts, sexing tables, delivery trucks and other hard surfaces. Leave all treated surfaces wet for 10 minutes or more. Wipe dry with a clean cloth or sponge or allow to air dry.

VEHICLES: Clean all vehicles including mats, crates, cabs and wheels with high pressure water and LONZA FORMULATION DC-110N. Use 2 - 3 oz. per gallon to treat all vehicles. Leave all treated surfaces wet for 10 minutes or more. Wipe dry with a clean cloth or sponge or allow to air dry.

SHOE BATH SANITIZER DIRECTIONS: Shoe baths containing one inch of freshly made solution should be placed at all entrances to buildings and hatcheries. Scrape waterproof work boots and place in a 2 - 3 oz. per gallon of water solution for 60 seconds prior to entering the area. Change the solution in the bath daily or more often if the solution appears diluted or soiled. DRESSING PLANT DISINFECTANT DIRECTIONS: Disinfect equipment, utensils, walls and floors in poultry and animal dressing plants. Disinfect offal rooms, exterior walls and loading platforms of dressing plants. Cover or remove all food and packaging materials. Remove all gross soils. Saturate all surfaces with the recommended use solution of 2 oz, per gallon. Scrub to loosen all soils. Allow to soak for 10 minutes and thoroughly rinse all wetted and cleaned surfaces with potable water. Wipe dry with a clean cloth or sponge or allow to air dry.

## SANITIZING HATCHERY ROOMS USING FOGGING DEVICES

Remove all animals and feed from premises, vehicles and enclosures. Remove all litter and manure from floors, walls and surfaces of the room to be treated. Empty all troughs, racks and other feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Close room off so fog is confined to room to be treated. Mix four parts LONZA FORMULATION DC-110N to five parts water (2 gallons of LONZA FORMULATION DC-110N to 2.5 gallons water). Insert the nozzle of the fogger through a suitable opening into the room. With the setting in maximum output, fog for one minute for each 4000 cubic feet of space in the room. When fogging is completed, ventilate buildings, and other closed spaces. Do not house livestock or employ equipment until treatment has been absorbed or dried.

### SANITIZING INCUBATORS AND HATCHERS USING FOGGING DEVICES

Mix 24 oz. LONZA FORMULATION DC-110N to 122 oz. water. Fog 3 - 8 oz. of this into setters and hatchers immediately after transfer. Repeat daily in setters and every 12 hours in hatchers. Discontinue hatcher treatments at least 24 hours prior to pulling the hatch. Do not allow people to contact or breathe this fog and do not enter until the fog has settled (30 - 60 minutes after fogging is completed). It is acceptable to fog setters and hatchers with a 2 - 3 oz. per gallon solution of LONZA FORMULATION DC-110N on an hourly or every other hour basis. If this is done, fog for 30 - 90 seconds once per hour or once every two hours. When fogging is completed, ventilate buildings, and other closed spaces. Do not house livestock or employ equipment until treatment has been absorbed or dried. Thoroughly scrub all treated feed racks, mangers, troughs, automatic feeders, fountains and waterers with soap or detergent, and rinse with potable water before reuse.

NOTE: The fog generated is irritating to the eyes, skin and mucous membranes. Under no circumstances should a room or building be entered by anyone within two hours of the actual fogging. If the building must be entered, then the individuals entering the building must wear a self contained respirator approved by NIOSH/MSHA, goggles, long sleeves and long pants.

FOGGING IS TO BE USED AS AN ADJUNCT TO ACCEPTABLE MANUAL CLEANING AND DISINFECTING OF ROOM AND MACHINE SURFACES.


