SWIMMING POOLS AND OUTDOOR SPAS

Add Lonza Barquat 1552-50% directly to the pool water along pool edges while filter and pump are in operation. To provide time for even distribution in the pool water, bathers must wait a minimum of 15 minutes after Lonza Barquat 1552-50% addition before entering the pool.

For pools and spas with visible algae, add 14 fluid ounces of Lonza Barquat 1552-50% for every 10,000 gallons of water (5 ppm active quaternary). After 24 hours, remove dead algae by cleaning. If algae is still present, repeat dosage as necessary.

Alternatively, apply 0.1-20 gallons of Lonza Barquat 1552-50% per 100,000 gallons of white water to be treated, which corresponds to a water concentration of 0.5 - 100 ppm. Make additions of Lonza Barquat 1552-50% by slug feeding at a point in the system where mixing action is good. Repeat dosage as often as necessary to maintain control.

Badly fouled process systems must be cleaned before initial treatment.


