When used as directed, **DANTOBROM S GRANULAR** will disinfect spa and hot tub water, keeping it clean, clear and free of odor. **DANTOBROM S GRANULAR** gives the effectiveness of chlorine without the chlorine odor. Proper sanitary practices require changing spa water at a minimum of every 30 days.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

NOTE: Before using **DANTOBROM S GRANULAR** in your spa or hot tub for the first time, add 4.6 fl. oz. of a 32% sodium bromide solution (or 0.09 lbs [1-½ ounces] of solid sodium bromide) per 300 gallons of water to establish a 30 ppm bromide concentration. Add sodium bromide at this dosage whenever the spa or hot tub is drained and refilled. The bromide addition ensures immediate establishment of an allbromide system, eliminates chlorinous odors and maximizes skin and eyes comfort.

SPA OR HOT TUB START-UP: To start up a new spa or hot tub, or one recently drained, clean all surfaces, backflush or clean the filter, chemically balance the calcium hardness and total alkalinity, treat for metals if present (iron, copper and manganese), and adjust the pH to 7.2 - 7.8.

Using a suitable feeder adjusted according to the manufacturer's directions, add Dantobrom S Granular to maintain an active bromine concentration of 2 to 4 ppm in residential spas and 3 to 6 ppm in commercial spas. Use a reliable test kit to monitor for bromine regularly.
