The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the conditions listed below:

Proposed Amendment

- Update First Aid Statements per PR Notice 2001-1
- Minor label changes

Conditions

Revise the label as follows:

1. Revise the Precautionary Statements by revising the statement "To protect eyes wear goggles or face shield, and to protect skin, wear rubber gloves when handling." to read "Wear protective eyewear (goggles, face shield, or safety glasses), protective clothing, and rubber gloves when handling."
2. Revise the Container Disposal section to read:

Container Disposal:

Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

A stamped copy of the labeling accepted with conditions is enclosed. Submit three(3) copies of your final printed labeling before distributing or selling the product bearing the revised labeling.

**PECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC
ANIMALS**

DANGER. CORROSIVE: Causes irreversible eye damage and skin burns. Do not get in eyes, on skin or on clothing. To protect eyes wear goggles or face shield, and to protect skin, wear rubber gloves when handling. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

FIRST AID

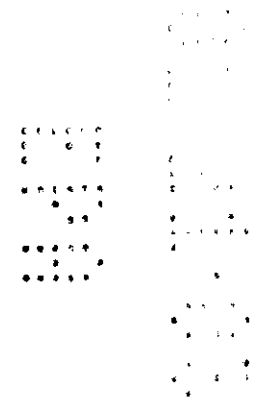

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

RSP Bio Strips are for use in drain pans of many cooling units such as air conditioners and refrigerators.

RSP Bio Strips are for use in toilet bowls and urinals. Controls foul smelling odors caused by mildew, fungi, bacteria, algae and slime.

For use in hotels, motels, schools, colleges, hospitals, nursing homes and airports. Effective against odor-causing bacteria.

For use in floor drains found in food processing plants, bars & restaurants. (RSP Bio-Strips can be formed into rings fitting the floor drains.)

For use in beer keg & soda dispenser overflow drains to prevent (mal-) odors (caused by) (from) odor-causing bacteria.

RSP Bio Strips is a controlled release product that easily fits into (most) (many) air conditioners or refrigerator drip pans or the water tank of your dehumidifier.

Because of the controlled release mechanism, RSP Bio Strips II will last for up to six months effectively maintaining clean water and inhibiting the foul odors caused by mildew.
