Dantobrom TBS is a new form of brominating hydantoin for toilet bowls. When used as directed, Dantobrom TBS will sanitize toilet bowl water, keeping it clean, clear and free of odor. Dantobrom TBS gives the effectiveness of chlorine without the chlorine odor. Dantobrom TBS sanitizes toilet bowl water by killing 99.9% of all germs within one minute after each flush.
