Page 1:

Under "Storage and Disposal", the heading, "PESTICIDE STORAGE or STORAGE" needs to be added preceding the "Pesticide Disposal" section with the following statements, "Open dumping is prohibited" and "Store in original container in areas in accessible to children." Also, the statement, "Do not reuse empty container," should appear as the first sentence under the "Container Disposal" instructions

Page 2:

- a. 4^{th} claim: the site, institutions, is too broad.
- b. 12th claim: when you list organisms which are killed by this product, you must always use the organism's complete scientific name, genus and species, which may be followed by shortened/abbreviated name in parenthesis. For example, *"Pseudomonas aeruginosa (Pseudomonas)"*. You may not use the abbreviated name alone.

Page 4:

- a. The "Disinfection" heading should be revised by replacing "Mold and Mildew Control" with "Fungicidal."
- b. Since this product may be used as a disinfectant in food contact areas, you will need to address the following comments:

POULTRY (and SWINE) PREMISE SANITATION

SITE PREPARATION

The first step in any on-going sanitation program should be the removal of gross contamination and debris. This may be accomplished using a shovel, broom, or vacuum depending on the area to be disinfected. The efficacy of even the most efficient germicidal cleaner is reduced in the presence of heavy organic matter, Once the heavy debris is eliminated, disinfection can be accomplished in one easy sten.

Remove all animals and feed from premises, vehicles and enclosures. Remove all litter and manure from floors, walls and surfaces of the room to be treated. Empty all troughs, racks and other feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Close room off so fog is confined to room to be treated. Mix four parts LONZA FORMULATION DCN 400-64 to five parts water (2 gallons LONZA FORMULATION DCN 400-64 to 2.5 gallons water). Insert the nozzle of the forger through a suitable opening into the room. With the setting in maximum output, fog for one minute for each 4000 cubic feet of space in the room.

SANITIZING INCUBATORS AND HATCHERS USING FOGGING DEVICES

It is acceptable to fog setters and hatchers with a 2 ounces per gallon solution of LONZA FORMULATION DCN 400-64 on an hourly or every other hour basis. If this is done, fog for 30-90 seconds once per hour or once every two hours. When fogging is completed, ventilate buildings, and other closed spaces. Do not house livestock or employ equipment until treatment has been absorbed or dried. Thoroughly scrub all treated feed racks, mangers, troughs, automatic feeders, fountains and waterers with soap or detergent, and rinse with potable water before reuse.

> NOTE: The fog generated is irritating to the eyes, skin and mucous membranes. Under no circumstances should a room of building be entered by anyone within two hours of the actual fogging. If the building must be entered, then the individuals entering the building must wear a self contained respirator approved by NIOSH/MSHA, goggles long sleeves and long parts. FOGGING IS TO BE USED AS AN ADJUNCT TO ACCEPTABLE MANUAL
