The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following comments:

- 1. Please note that at your next printing of final label, the "First Aid" statements must be in compliance with PR Notice 2000-3. The statements must read as follows:

FIRST AID STATEMENT

"IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a Poison Control Center or doctor for treatment advice.

"IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a Poison Control Center or doctor for treatment advice.

"IF SWALLOWED: Call a Poison Control Center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told by a Poison Control Center or doctor.

"IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a Poison Control Center or doctor for further treatment advice.



DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Dantogard Plus Liquid preserves and aids in the control of bacteria and fungi in liquid detergents, fabric softeners, household cleaning products, soft soaps, water-based paints for household and industrial use, room deodorizers and air fresheners, water-based surfactants, polymer emulsions, protective or decorative coatings, water-based gels for household and industrial products, textiles, water-based adhesives, latex for paper coatings, and water-based inks. This product is not cleared by the Federal Food, Drug and Cosmetic Act for use on food-contact paper and adhesives.

Dantogard Plus Liquid should be added to the formulation to be preserved at a rate of 2.0 to 20.0 lbs. per 1000 lbs. or 0.2% to 2.0% or 2,000 to 20,000 ppm based upon the total weight of the product to be protected.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Keep container closed. Store in a dry place. Do not store at elevated temperatures. Keep from freezing.

Pesticide Disposal

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal

Triple rinse (or equivalent). Then offer for recycling or reconditioning or puncture and dispose of in a sanitary landfill or incineration or if allowed by state and local authorities, by burning. If burned, stay out of smoke.
