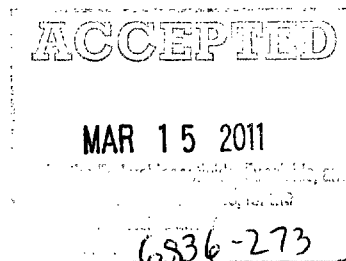

PRECAUTIONARY STATEMENTS

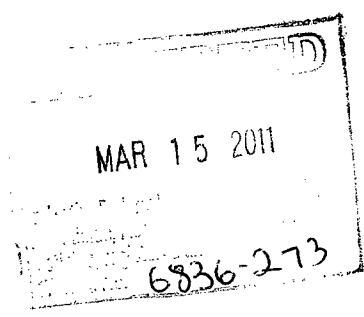
