The Agency has reviewed your submission in accordance with continuing registration under the Federal Insecticide Fungicide and Rodenticide Act (FIFRA), as amended, and determined the action acceptable.

In summary, your request to update the ingredient statement, revise a Precautionary Statement and update your Storage and Disposal directions on the label has been accepted with conditions. Please revise your label accordingly: Correct the spelling of "cleaning" and "visible" and delete typo "t" on page 3.

In addition you have revised your basic Confidential Statement of Formula (CSF). The data submitted in support of the label declarations, were reviewed and deemed acceptable. A copy of our review, D383851, is enclosed.

The Certification with Respect to Child Resistant packaging was placed into review and will be evaluated at a later time.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER. HIGHLY CORROSIVE. Causes irreversible eye damage and skin burns. May be fatal if swallowed. Do not take internally. Irritating to nose and throat. Avoid breathing dust. Use with adequate ventilation. Do not get into eyes, on skin or clothing. Wear rubber gloves when handling. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To Sanitize, Clean, and Deodorize:

Flush toilet, [When water level in tank is low, drop tablet into tank near sidewall closest to float and away from water valve opening] [right rear corner of the tank]. When tablet has dissolved, replace with a new tablet. Each tablet sanitizes for 13 weeks.
