Dear Ms. Henson:

I am submitting an application to update the storage and disposal language for the abovementioned product. The language has been updated according to PR Notice 2007-4 for ready-to-use products. Dantochlor TBS-4 is not currently in production. Therefore, we are unable to send CRP information for household/residential use to the Agency for review. As explained on the enclosed "Certification of Child-Resistant Packaging," Lonza will submit that information should a distributor be found.

Additional changes have been made to the label:

- Update pathogen nomenclature to Salmonella enterica;
- Add optional Spanish signal word;
- Add optional language and/or placeholders for DOT symbols, Country of origin, Manufactured in, and Barcode;
- Add Notes to Reviewer regarding marketing language;
- Add note to reviewer and the following optional Spanish language statement and English translation: Si usted no entiende la etiqueta, busque a alguien para que se la explique a usted en detalle. [If you do not understand the label, find someone to explain it to you in detail.]
- Add optional diagram which shows tablet placement in the tank.


