On behalf of Lonza Inc, we are submitting are re-submitting a Pesticide Notification for the product **Dantochlor TBS-5** (**EPA Reg. No. 6836-288**). In response to your letter dated November 29, 2006, (attached) we have removed the claim "Powerful" from the label and propose the following changes to the label:

- 1) Add minor optional language to clarify the directions for use. Please note these additions do not conflict with language that is approved but merely clarify or reiterate the currently approved directions for use.
