Change "Kills E. coli" to read "Kills Escherichia coli (E. coli)"

In addition you have revised your basic Confidential Statement of Formula (CSF). The data submitted in support of the label declarations, were reviewed and deemed acceptable. A copy of our review, D383862, is enclosed.

The Certification with Respect to Child Resistant packaging was placed into review and will be evaluated at a later time.


