APPLICATION

GLYBROM PG-100 POWDER should be added to process water streams at or immediately prior to a point of sufficient mixing such as the fan pump or wire pit.

Standard powder feeders can be used for **GLYBROM PG-100 POWDER** applications. Make-up, machine white waters, thick stock and returning clarified dilution waters are typical examples of acceptable treatment waters.
