Adding organisms and label claims

Conditions

Revise the label as follows:

- 1. Review the 20th, 21st, and 28th claims on page 10 by deleting the term, "Power" because it implies heighten efficacy.
- 2. Revise the 34th, 35th, 36th, and 37th claims by deleting the phrase, "the Flu" and/or "Flu Virus," and state "Influenza Type A/Brazil, the flu virus"
- 3. Revise the 35th, 36th, 37th claims by deleting the phrase, "with Mr. Clean," because it implies heighten efficacy.
- 4. Revise the 8th claim on page 10 and the 1st claim on page,11 by deleting the phrase, "Stay Healthy."
- 5. Delete the 3rd, 7th, 8th, and 9th claims on page 11.

6. Revise the 4th claim on page 11by deleting the phrase "for a deep cleaning,"

- 7. Revise the 5th claim on page 11 by deleting the terms "Life's" and "Everyday."
- 8. Revise the 6th claim on page 11 to read "Kills (Wipes Out) (99.0%) (of) (Rotavirus, the diarrhea causing virus) (Listeria) (MRSA) (Methicillin Resistant S. aureus) (Norwalk)."
- 9. Revise the 6th claim on page 14 to bring it into compliance with PR Notice 2000-5, Mandatory Language by deleting the term, recommended, and state "(Clean at 120°F...replacement)".
- 10. Delete the organism, Healthcare Associated Methicillin Resistant S. aureus" on page 16. The organism is known as S. aureus Methicillin Resistant (MRSA)
- 12. Revise the statement, Not recommended for use on unpainted wood," on page 19 to be incompliance with PR Notice 2001-1, Mandatory Labeling, by stating "Do not use on unpainted wood."

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

Adding organisms and label claims

Conditions

Revise the label as follows:

- 1. Revise the 24th bullet on page 7 to bring it into compliance with PR Notice 2000-5, Mandatory Language by deleting the term, recommended, and state "(Clean at 120°F...replacement)".
- 2. Revise the statement, "Not recommended for use on unpainted wood," on pages 9 and 11 to be incompliance with PR Notice 2001-1, Mandatory Labeling, by stating "Do not use on unpainted wood."
- 3. The Agency has revised our policy on Avian Influenza A virus such that ready-to-use and wipe products may support claims provided the data is acceptable and the label clearly indicates that the product cannot be used to treat large surface areas such as floors and walls as well as hard nonporous surfaces which are not conducive to treatment by immersion or excess liquid. Therefore, this claim is not appropriate for treatment in animal premises, and you must delete the ated directions on page 12. However, you may treat "high touch" hard nonnorous surfaces
