It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Isocil WT is for use as an industrial mildewcide in coatings, paints, building materials, wallpaper pastes and adhesives, aqueous adhesives and tackifiers.

Do not use treated material for construction of honey bee hives.

#### COATINGS

For use as a mildewcide in coatings such as wood coatings, wood coating solutions, latex and solvent-based paints, semi-transparent stains and solid stains. Use 1.0 to 3.0 pounds of ISOCIL WT per 100 gallons of coating formulation. If necessary, a higher dosage up to 4.0 pounds of ISOCIL WT per 100 gallons may be used depending upon level of control required.

In latex coatings, ISOCIL WT should be added during the letdown phase of paint manufacture. To ensure uniform distribution throughout the coating, it is recommended that ISOCIL WT be premixed with propylene glycol and coalescent.
