

DIRECTIONS FOR USE:

For use in formulating disinfectants, algaecides, fungicides, bactericides and / or slimicides for recirculating water systems, antimicrobials for pulp and for manufacture of food and non-food grades of paper and paperboard, and in enhanced oil recovery in non-estuarine waters.

Reformulated or repackaged products must be registered with EPA. The registrant must supply data required for their own registration.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **PESTICIDE STORAGE**:
