For the control of slime forming and sulfate reducing bacteria in oil field water flood or salt water disposal systems, add 5-10 ppm (active) **BARDAC 2250M** (1- 1/2 - 3 gallons per 3000 barrels of water) continuously. Levels for effective control will vary depending on conditions at the site.


