b. Revise the label as required per efficacy review:

The efficacy data submitted to support bactericidal claims were developed with the AOAC Germicidal Spray Test, therefore, it can only support spray applications. Applications such as spray floor mops, cloths, fogging, etc. are not acceptable.

Directions for Use and Claims should be placed together in separate categories. In other words, place all directions and uses for disinfection together, all odor claims together, all sanitizing claims together, do not mix and match. This is confusing to the consumer

Page 3- Is effective at controlling mold and mildew odor on mattresses, pillows is not acceptable. This is misleading to the consumer, these are porous materials.

Page 3- Remove all claims that state reduction in cross contamination. The statement can say reduces cross contamination on treated surfaces.

Page 3- Remove "This product may be applied through low-pressure sprayers, and fogging (wet misting) systems." The product was not tested under this condition.

Page 4- "To disinfect food process facilities: Spray surfaces with solution and allow to remain wet for 3 minutes. Rinse food contact surfaces with potable water prior to reuse" must be deleted from the label. This product was not tested as a food contact surface sanitizer and cannot be used on food contact surfaces.

Page 5- Remove all references for use with spray floor mops.

Page 5- Delete is effective at eliminating odors on porous surfaces such as upholstery, drapes, carpets, bedding, mattresses and non-porous surfaces such as walls and floors. Excellent for fire restoration. This is misleading to the consumer. Odor causing claims are not considered human health related, but nevertheless should bear accurate labeling claims and adequate dosage recommendations, and complete directions for a practical pattern of use.

Page 9- The phrase "Bactericidal Stability of Use-Dilution" must be removed. Data were not submitted to support this claim.

Page 9- For use on finished floors must be removed, application with spray floor mop was not supported with efficacy data.

Page 9- Adenovirus Type 5 and 7 must be deleted because they were not supported by efficacy data.

Pages 13 & 14- All Bacteria should have the same contact time as well as viruses should all have the same contact time. Too many contact times are confusing to the consumer. A consumer will not know what bacteria or virus may be on surface to be treated.

Page 3 EPA Reg. No 6836-349

Legionella pneumophilia must be deleted because it was not supported by efficacy data. Avian Influenza Virus was not supported by efficacy data; therefore all references to Avian Influenza Virus (H3N2), Avian Influenza Virus (H5N1), and Pandemic 2009 H1N1 must be deleted from the label. See Agency Guidelines for adding Pandemic 2009 H1N1 to label.

Page 14- Reference to SARS in the table must be removed. The coronavirus tested (Human Coronavirus Strain 229E) is not associated with SARS. Examples of acceptable labeling can be found on the EPA website.

Page 14- Reference to ESBL *Escherichia coli* in the table must be removed. Supporting data for this strain were not submitted.

c. Additional required label changes:

- Remove "[spray floor mops]" claim from page 3 and " "with a spray mop [system]" on page 9.
- Delete the 5th bullet from the bottom on page 5: "in the laundry to control odors on musty bedding ad linens..." It is false and misleading, because bedding and linens are porous surfaces.
- Revise the statement "Rinse all surfaces that come in contact with food such as countertops..." on page 8 by deleting "...all surfaces that come in contact with food such as..." because your product is not food-contact use product.
- Under DEODORIZING DIRECTIONS heading on page 12 delete the statement "Spray mopping solutions:....allow surface to dry"

A stamped copy of the accepted labeling with conditions is enclosed. Submit 1 copy of your final printed label before distributing or selling the product bearing the revised labeling.

If the above conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6 (e).
