

The maximum number of applications per growing season is 6 at a minimum of retreatment interval of 18 days. ARTICHOKES (annuals): Band application in borders and around perimeter of crop. The maximum application rate is 33.3 pounds product (1.0 lb ai)/A per application. The maximum number of applications per growing season is 2 at a minimum of retreatment interval of 18 days.

BERRIES:

Blueberries: Band application in borders and around perimeter of crop.


Lettuce, Cole Crops, And Other Leafy Greens: (broccoli, Brussels sprouts, cabbage, cauliflower, cavalo, broccolo, collards, kale, kohlrabi, mizuna, mustard greens, spinach, rape greens): Band application in borders and around perimeter of crop. The maximum application rate is 33.3 pounds product (1.0 lb ai)/A per application. The maximum number of applications per growing season is 3 at a minimum of retreatment interval of 14 days.

GRASS GROWN FOR SEED: Broadcast application (uniform application to entire area) The maximum application rate is 26.6 pounds product (0.8 lb ai)/A per application. The maximum number of applications per growing season is 4 at a minimum of retreatment interval of 21 days. Applications to turfgrass (other than grass grown for seed or in State and/or Federal invasive mollusk eradication operations) are prohibited.

TOMATOES: Band application in borders and around perimeter of crop. The maximum application rate is 33.3 pounds product (1.0 lb ai)/A per application. The maximum number of applications per growing season is 3 at a minimum of retreatment interval of 14 days.
