FIRST AID



HOW TO APPLY

- Place pellets on the soil surface as recommended in the graphics below
- Do not apply pellets in piles that may attract pets.
- Reapply as indicated in chart. Heavy infestation or areas heavily watered may require reapplication.
- Do not re-water for 48 hours after application
- Do not apply directly to or contaminate edible portions of the plant




