Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Triple rinse as follows: Empty remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

For Control of Mildew In Non-Food-Contact Polymer Systems (such as PVC, etc.): To inhibit mildew and other fungi growth, a dosage of up to 4.4% by weight (total formulation weight) of this product is recommended [4.4% of this product provides a concentration of 0.22% (2200 ppm) active ingredient]. It may be added at the time plasticizer is added or after dry blending. Decrease the amount of plasticizer added to your formulation by the amount of plasticizer added by this product.
