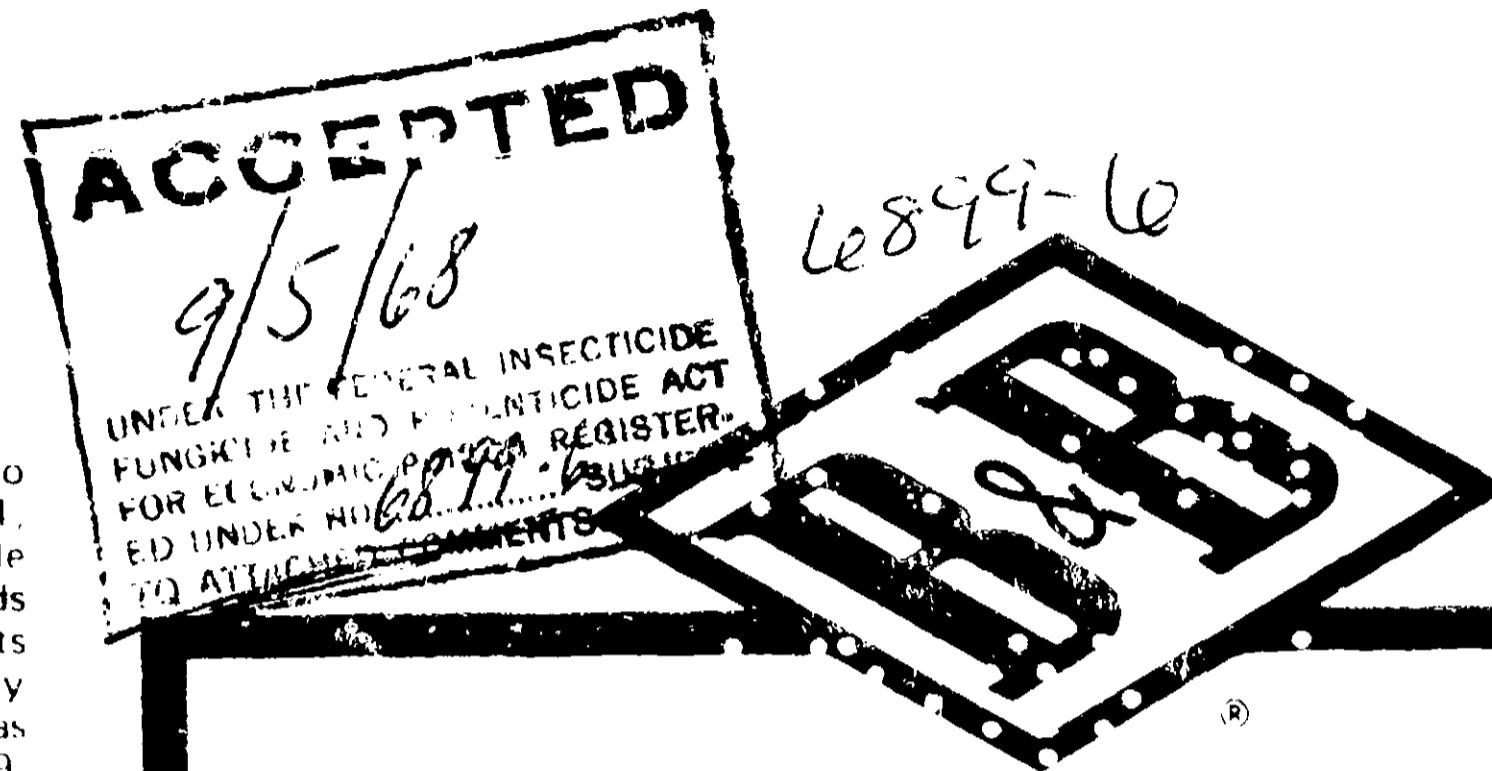


**SAPONIFIED CRESOL SOLUTION**

B&B CRESO 16-N conforms to Commercial Standard CS71-14, Group 1, entitled "Phenolic Disinfectant (Soluble Type)". This Bureau of Standards specification is designed to cover products meeting Bureau of Animal Industry requirement for permitted disinfectants as provided by Sec. 71-11, Chapter 1, Title 9, Code of Federal Regulations. B&B CRESO 16-N has been permitted for use in official disinfection under BAI ORDER 309 ("Regulations Governing the Interstate Movement of Livestock.")

**DIRECTIONS:** For use as a general disinfectant use 2 to 4 ounces B&B CRESO 16-N to one gallon of water. This is equivalent to from 4 to 8 tablespoonfuls per gallon of water, or 1 to 2 tablespoonfuls per quart of water. On a solution basis it is equivalent to 1 part B&B CRESO 16-N in 30 to 60 parts water. Stir well particularly when using very cold water to insure complete dispersion. In applying B&B CRESO 16-N solution wet thoroughly all surfaces treated. For official disinfection under BAI Order 309, use not less than four ounces of B&B CRESO 16-N to one gallon of water. Mix well to insure complete solution.

**ANTIDOTE** Internal - Give a tablespoonful of salt in a glass of water and repeat until vomit is clear. Give milk or white of eggs beaten with water. Have patient lie down and keep warm. CALL A PHYSICIAN  
External - Wash immediately with soap and water, working up good rich suds, then rinse well. If in eye flush with copious quantities of water and consult physician.
