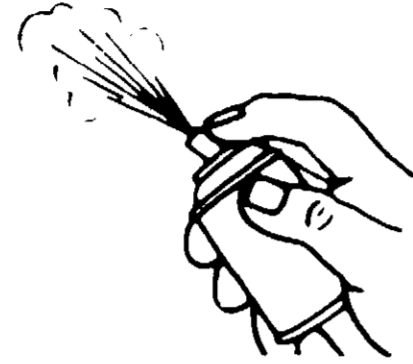

ACTIVE:

Pyrethrins I & II	5.00%
* Technical Piperonyl Butoxide	4.00%
Refined Petroleum Oil	8.00%

INACTIVE:

	87.50%
* Equivalent to 3.2% (Butylcarbityl) (6-Propylpiperonyl) Ether and .8% of Related Compounds.	

DIRECTIONS

FLIES, MOSQUITOES, GNATS, WASPS, FLYING ADULT MOTHS: Obtain cubic feet of space to be treated. Example: 10' high x 10' long and 10' wide= 1000 cubic feet. Close doors and windows. Spray from 1 to 4 seconds per 1000 cubic feet. Disperse in all directions. If possible have fans operating to speed up circulation of aerosol fog throughout area being treated. Keep area closed for 15 minutes after treatment.

WEEVILS, FLOUR BEETLES, CHOCOLATE MOTHS, CARPET BEETLES, DRUG STORE BEETLES in exposed adult and larvae stages: Contact as many insects as possible when treating infested areas such as cracks, crevices, stored products, machinery, dark secluded areas. Spray 10 to 20 seconds per 1000 square feet of floor space. Repeat treatment weekly or as insects appear.

CAUTION

Contains concentrated insecticide under pressure. Therefore do not expose to temperatures above 130 F. Hold dispenser three feet away from object being sprayed to avoid possible staining. Cover unpacked foodstuffs or eating utensils to protect them from spray and dead or falling insects.

This cylinder is not refillable. Do not attempt to recharge. When cylinder is exhausted discard in safe place. Do not throw in fire.

To be used as a space spray in food processing plants only when the plant is not in operation.
