

DIRECTIONS

Remove protective cap. Holding container upright and away from you, tilt sprayhead until tip engages rim of valve mounting cup. Valve will remain in open position for total release of contents. Place in upright position in an elevated location such as on stand or table. Place newspaper under can to protect surface immediately around area of release. Release the contents of this can for each 5,000 cubic feet of unobstructed space. Use additional units for remote areas or where free flow of fog is not assured.

Close doors and windows, and turn off fans and air conditioners. Remove pets, and cover or remove fishbowls. Cover exposed foods, utansils, and food handling surfaces. Product can be used around food and utensils if they are protected from direct contact while spraying. Open cabinets and doors to expose spaces to be treated. Extinguish all flames except pilot lights. For best results, leave treated space undisturbed for two hours or more. After treatment, open doors and windows and allow to ventilate for 30 minutes.

Do not remain in treated area. See precautions on side panel.
