HAZARD TO HUMANS AND DOMESTIC ANIMALS

KEEP OUT OF REACH OF CHILDREN

DANGER. Corrosive. Causes skin irritation and irreversible eye damage. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful if swallowed. 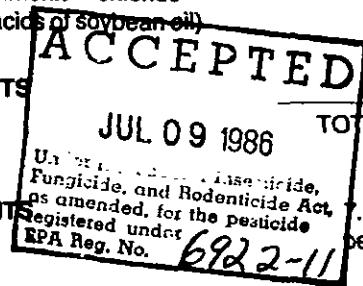

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse.

If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

STORAGE AND DISPOSAL

PROHIBITIONS

In case of spill or leak eliminate all ignition sources. Observe handling instructions given to prevent eye damage and skin burns. Do not contaminate food or feed by storage, disposal or cleaning of equipment.

STORAGE

Store drums in a sheltered area away from heat and cold. Use approved equipment for transport of drums to avoid puncturing or rupturing of container. Do not use air pressure to transfer.

PESTICIDE DISPOSAL
