Dear Mr. Ayer,

We have reviewed the labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, and pursuant to PR Notice 94-7. We have the following comments on it.

- 1. The wording of the "DIRECTIONS FOR USE" portion of the proposed revised label submitted for this product on December 14, 1994, is acceptable. When you print labels, make sure, under item "2." of "IMPORTANT", to insert a space between "obtaining bait." (end of second sentence) and "If bait" (beginning of third sentence).
- On the center panel of the label, note that "Anticoagulant" customarily is not hyphenated.
- 3. A general problem with the proposed revised "DIRECTIONS FOR USE", and with most of the remainder of the required label text, is that the print sizes used are rather small. It appears that the size of the label affords ample room for presenting required text in larger print as a considerable amount of space either has been left blank or is devoted to graphics.

Generally, these are along walls, by gnawed openings, in or beside burrows, in comers and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain or snow, Remove as much food as possible.

APPLICATION DIPECTIONS

PATS: Apply 4 to 16 oz. of bart per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days.
