IF SWALLOWED. Call a physician or Poison Control Center. Do not induce vomiting because of aspiration hazard.

PHYSICAL OR CHEMICAL HAZARD

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperature above 130°F may cause bursting. Do not spray on plastic, painted, or varnished surfaces or directly into electronic equipment such as radios, televisions, computers, etc.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Cessco's AccuDose specific dosage residual spray is for treatment into cracks, holes, crevices and similar small openings where these insects may be hiding, living and breeding.

With the rigid applicator extension placed into cracks, holes, crevices, and similar small openings where these insects may be a problem, release approximately 1 second of spray per spot in serious infestation areas. If possible, space these applications 12" apart. In lightly infested areas, or for preventive treatment, space three feet apart.

For use in homes, hospitals, food processing plants, restaurants, supermarkets, hotels, and motels. Care must be taken so no material comes in contact with exposed food products, equipment, or packaging materials. They must be removed or covered before use. Do not use in commercial food preparation areas or in edible product areas of food processing plants.

Do not use in food areas while food is exposed. Avoid contamination of food, utensils, and food preparation areas.

STORAGE AND DISPOSAL

Do not store near heat or open flame. Replace protective cap when not in use.

Do not reuse empty container. Wrap and place in trash collection.
