### **DIRECTIONS FOR USE**

FLOWERS AND ORNAMENTALS: For control of Aphids, Mites, Red Spiders, Thrips, Mealy Bugs, Leafhoppers, Tarnished Plant Bug, Four-lined Leaf Bug, Japanese Beetle adults. Soft Brown Scale and Monterey Pine Scale: Use 2 teaspoonfuls of Germain's 50% Malathion solution to 1 gallon of water. Spray directly on plants, thoroughly wetting both sides of leaves and other parts of plant subject to infestation by the pests. Repeat in 10 days as required to control.
