Super 94 (Spray Oil) is a straight-cut narrow boiling range petroleum oil designed specifically for use on deciduous fruit trees.

Apply so as to give total coverage to all parts of tree. Thorough drenching of trunks, limbs, twigs and leaves is essential for maximum insect control.

Use only in spray machines with powerful positive agitation. Keep agitator running at all times during spray operations. **Super 94 (Spray Oil)** is formulated as a "fast break" spray oil and will not stay in solution unless agitated constantly!

Super 94 (Spray Oil) may be used as a carrier for appropriate Insecticides and Fungicides which are registered for use on deciduous fruits and nuts and which can be applied to give a uniform spray. Consult your local Agricultural Extension Service.

DIRECTIONS FOR USE

Fill spray tank with ½ the required amount of water. Start agitator. Add total amount of spray oil. Continue operation of agitator while adding balance of water and while spraying.

Almonds, Apricots, Apples, Cherries, Nectarines, Olives, Peaches, Pears, Plums, Prunes, Walnuts (summer treatment only): Dormant Treatment: Brown Apricot Scale, Black Scale, San Jose Scale, Parlatoria Scale, Oleander Scale, Italian Pear Scale, Lecanium Scale, Aphid Eggs, Spider Mite. Apply 1½ to 2 gals. per 100 gals. of water. **Delayed Dormant Treatment: Pear Psylla. Apply 2 gals. per 100 gals. of water. **Summer Treatment. Spider Mites.** Apply 3 to 4 qts. per 100 gals. of water. **San Jose Scale, Italian Pear Scale, Pear Psylla.** Apply 1 to 1½ gals. per 100 gals. of water.**

Grapes: Dormant, Delayed Dormant, or Summer Applications. Mealybug. Apply 1 gal. plus 1 qt. of Parathion 4 EC or Parathion 4 Flowable.

To control insects on crops listed on this label apply 3 to 5 gallons of Super 94 (Spray Oil) in 50 to 100 gallons of water per acre.

Dormant and delayed dormant treatment only. Special concentrate spray equipment is necessary for this application.
