This combination fertilizer and weed control

- 1) Is a highly effective pre-emergent crabgrass control.
- 2) Control the following annual grasses and broadleaf weeds:

Annual Bluegrass	Green Foxtail	Texas Millet
Carpetweed	Johnsongrass (from seed)	Mitcham
Common Chickweed	Lambquarters	Yellow Foxtail
Fall Panic	Lovegrass	Spotted Spurge
Florida Parsley	Purslane	

The herbicide in this product is pre-emergent. It only kills annual weeds as they germinate. IT WILL NOT CONTROL WEEDS THAT HAVE ESTABLISHED.

- 3) Feeds your lawn for a more beautiful green color.

#### HOW TO USE

It is recommended that this product be applied after lawn has shown evidence of new sprouted lawn grasses. Lawns may be re-seeded 60 days after application. If the re-seeding is done in the 60 day period is elapsed, the amount of lawn seed should be increased by 50% to insure a good stand. Follow the same application procedure as directed for established turf lawn.

ESTABLISHING THE LAWN

WATER YOUR LAWN - FERTILIZER CONTROL, FERTIG SYSTEM

Prepare your lawn with a good thorough watering the day before application. This is essential.

GRASS - FERTILIZER WATER

So that the grass leaves are dry before application, apply fertilizer 10-15 days before watering. Water into soil thoroughly, but avoid excessive watering. To control annual bluegrass, common chickweed and other cracks or bare-patching grasses, use 1-1/2 rounds per 100 sq. ft.

APPLICATION PERIOD: Apply in early Spring before seedlings and other annual grasses and weeds germinate. For control of Fall germinating annuals such as annual bluegrass or common chickweed, apply in late January or early Fall.

TO MEASURE THIS MATERIAL

A one pound coffee can holds approximately 2 rounds of this material.
