DIRECTIONS FOR USE

Broadcast application may be made by ground equipment or aircraft. Treatments may be repeated as necessary. Apply recommended dosage for control of *cutworms*, *army-worms*, *crickets*, *darkling ground beetles*, *grasshoppers and sow bugs*.

Alfalfa, Peas: Apply 30 lbs. per acre. No time limitation.

Asparagus, Strawberries: Apply 40 lbs. per acre. Do not apply within 1 day of harvest. Beans, Carrots, Corn, Eggplant, Okra, Peppers, Potatoes, Tomatoes, Sweet Corn: Apply 40 lbs. per acre. No time limitation.

Broccoli, Brussels Sprouts, Cabbage, Cauliflower, Head Lettuce, Garden Beets (roots), Horseradish, Parsnips, Radishes, Rutabagas, Turnips (roots): Apply 40 lbs. per acre. Do not apply within 3 days of harvest.

Cucumbers, Squash, Melons, Peanuts: Apply 20 lbs. per acre. No time limitation. Sugar Beets, Collards, Endive (escarole), Garden Beets (tops), Kale, Leaf Lettuce, Parsley, Spinach, Swiss Chard, Turnips (tops): Apply 40 lbs. per acre. Do not apply within 14 days of harvest.


