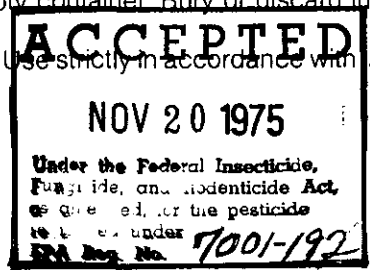

### DIRECTIONS FOR USE

Pentac WP is a specific miticide that is very effective against the two-spotted mite. In the greenhouse, it is recommended for use on roses, chrysanthemums, gardenias, carnations, azaleas, delphiniums, snapdragons, zinnias and poinsettias. It is also effective on outdoor roses and nursery arborvitae, including hemlock and spruce. Pentac WP has a long residual activity.

Pentac WP should be applied at a rate of 8 ounces per 100 gallons of water on greenhouse roses, and two applications with thorough coverage should be made about two weeks apart for optimum results. From 2,000 to 3,000 mature bushes should be sprayed with 100 gallons of the mixture.

Because other floral greenhouse crops are grown under cooler conditions, only one eight ounce application of Pentac WP may be required. It is recommended that a single application with thorough coverage be made initially on these crops listed above unless the mite problem is severe, in which case two eight ounce applications should be made as is suggested for roses. A similar single treatment on nursery stocks - including arborvitae - gives excellent mite control.

For outdoor use on nursery arborvitae, hemlock, roses and spruce, apply 8 oz. per 100 gallons of water.

As Pentac WP is compatible with most other commonly used materials, it may be applied from regular greenhouse sprayers.

### DESCRIPTION

Pentac 50 WP is a specific miticide for use on greenhouse floral crops and outdoor nursery stock. See directions for crops. Pentac 50 WP has a long residual activity.
