DIRECTIONS FOR USE

Read entire label before using. Use strictly according to directions and cautions. Open protective cap, point opening away from you and squeeze. Apply in short puffs in sweeping motion. Cover foliage lightly but do not over apply. Make certain that upper and lower leaf surfaces are thoroughly covered. Shake container frequently to keep dust free flowing and prevent packing. () circled number indicates days between last use and harvest.

TOMATOES (5): INSECTS: Aphids, Colorado Potato Beetle, Two Spotted Mite, Tomato Russet Mite, Drosophilia, Tomato Fruitworm, Tomato Hornworm, European Corn Borer, Stink Bugs, Flea Beetles, Leafhoppers, Armyworm. DISEASES: Early Blight, Late Blight, Leaf Spot, Anthracnose. For disease control begin at first fruit cluster and repeat at 7 to 10 day intervals.


BEANS (4): INSECTS: Aphids, Leafhopper's, Lygus Bugs, Bean Leaf Beetle, Stink Bugs, Armyworms, Corn Earworms, Flea Beetles, Cucumber Beetles, Two Spotted Mites. DISEASES: Downy Mildew, Rust, Anthracnose. For disease control, begin when plants are small and repeat at 5 to 7 day intervals.

SWEET CORN (5): Corn Earworm. Apply when silks first appear. Repeat at 2 to 3 day intervals during silking period. Do not feed or graze corn forage.

BROCCOLI (7), BRUSSEL SPROUTS (7), CABBAGE (7), CAULIFLOWER 15; INSECTS: Aphids, Leafhoppers, Stink Bugs, Armyworms, Diamond Back Moth, Corn Earworms, Flea Beetles, Imported Cabbage Worms, Tarnished Plant Bug, Cabbage Loopers. DISEASES: Downy Mildew, Alternaria Leafspot. Begin when disease threatens and repeat at 7 to 14 day intervals. LETTUCE (14), SPINACH (14): INSECTS: Aphids, Leafhoppers, Lygus Bugs, Flea Beetles, Stink Bugs, Armyworms, Corn Earworms, Cabbage Loopers. DISEASES: Downy Mildew, Tarnished Plant Bug. Remove residues from head lettuce by stripping and trimming, and from leaf lettuce and spinach by washing or other effective means. Begin when disease appears and repeat at 7 to 10 day intervals.

CUCUMBERS (5), MELONS (5), SQUASH (5), PUMPKINS (3): INSECTS: Aphids, Leafhoppers, Thrips, Cucumber Beetles, Pickleworms, Flea Beetles, Melonworms, Squash Vine Borers, Two Spotted Mites. DISEASES: Downy Mildew, Cercospora Leafspot (Melons only), Anthracnose (Cucumbers, Melons & Squash only). Begin when disease threatens or plants begin to run and repeat at 7 to 10 day intervals.
