DIRECTIONS FOR USE

Apples: *Scab.* Apply 20 to 40 lbs per acre. Apply in late cover application or as necessary. *Note:* May cause russeting on golden delicious and grimes golden. Do not apply within 5 days of harvest. Do not graze cover crop in treated orchards. Do not use treated apple pomace for use in livestock feeds.

Cherries: *Leaf Spot.* Apply 40 to 60 lbs. per acre. Apply at petal fall or when leaves first appear. Repeat at 7 to 10 day intervals. Do not apply when temperature and humidity are excessively high.

Pears (Western states only): *Scab.* Apply 50 lbs per acre. Begin in pre-bloom stages. Repeat at 5 to 7 days through first cover spray. Do not apply within 5 days of harvest. Do not graze cover crop in treated orchards.

Strawberries: *Leaf Blight, Leaf Scorch, Leaf Spot.* Apply 25 to 30 lbs per acre. Begin as soon as new growth starts. Repeat at weekly intervals as necessary. Do not apply within 14 days of harvest.

Roses: *Black Spot.* Apply 8 to 10 lbs. per acre. Make first application when young leaves first appear. Repeat at 7 to 10 day intervals throughout season. *Caution:* Higher dosage may cause stunting and defoliation on first year plants and chlorosis on older established plants.

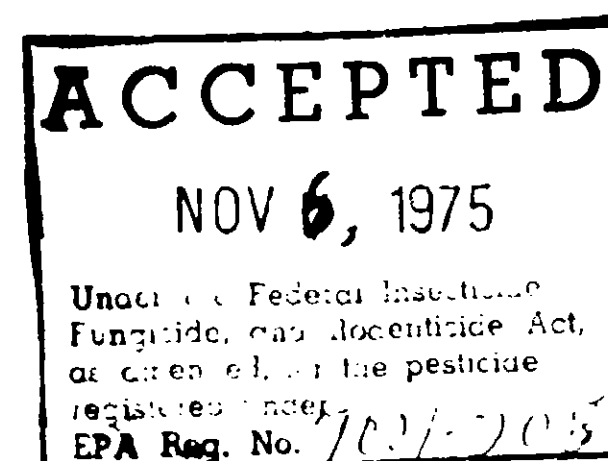
