
DIRECTIONS FOR USE

This product is formulated for application by ground.

Coffee: Leaf Rust (Brazil). Apply 46 to 159 lbs. per acre at 3 to 4 week intervals from September to March as necessary.

Pears (Western States): Fireblight. Apply 20 ibs. per acre at 5 day intervals throughout bloom period. Caution: Excessive dosages may russet fruit.

Peppers: Bacterial Spot (Xanthomonas). Apply 42 to 62 lbs. per acre when disease threatens. Repeat at 7 to 14 day intervals.
