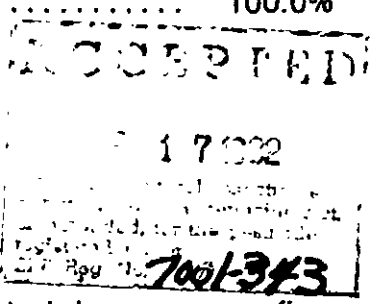
## Technical Grade

**ACTIVE INGREDIENT:**  
Sodium Chlorate ( $\text{NaClO}_3$ ) ..... **BY WT. 100.0%**

**DANGER**

Strong oxidizer. Contact with other material may cause fire.  
Causes irritation. May be fatal if swallowed.



### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Avoid contact with eyes, skin and clothing. Keep from contact with clothing and other combustible materials. Wash thoroughly after handling. Use goggles, rubber gloves and rubber shoes.

### CHEMICAL HAZARDS

Store in a cool, dry fire resistant area separate from organic chemicals, mineral acids, powdered metals, and combustibles.

Do not reuse empty drum.

### IN CASE OF:

**FIRE** - Flood with water. Do not use  $\text{CO}_2$  or dry smothering type powders. They are not effective.

Material decomposes above  $570^\circ\text{F}$  ( $300^\circ\text{C}$ ) liberating oxygen.

If clothing catches fire drench with water. Do not use fire blankets. They are not effective.

**SPILL** - Shovel up and place in a clean, dry metal container. Flush spill area with large quantities of water.

### FIRST AID

In case of contact, immediately remove contaminated clothing and shoes. Flush skin with plenty of water.

In case of eye contact, immediately flush eyes with water for at least 15 minutes. Call a physician.

If inhaled, remove to fresh air.

If swallowed, induce vomiting by placing a firm object against back of throat. Avoid all stimulants. Keep patient warm. Do not give anything by mouth to an unconscious person.

Contaminated clothing should be kept wet until washed.

Wash clothing before reuse. Discard nonrubber shoes.
