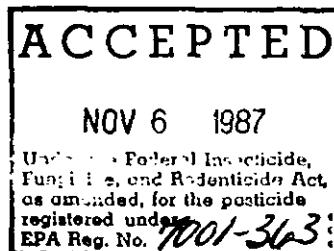

Tidal waters, marshes, swamps and waters high in organic content, 10 lbs. per acre. Highly polluted waters, 25 lbs. per acre. Apply uniformly by air or ground equipment. Repeat applications as necessary.

For control of Gnat, Punkie, Sandfly apply at the following rate: Marsh lands, margins of streams, intertidal zones of sandy beaches 5 to 10 lbs. per acre. Apply uniformly by ground or air equipment. Repeat applications as necessary.
