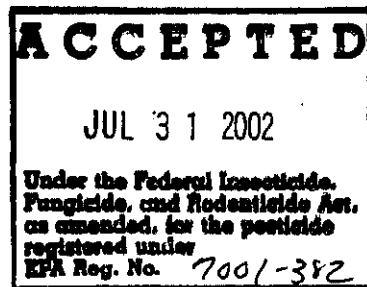

Not for use on dichondra or stands of predominately fine fescue. Not for use on tall fescue during the warm summer months in the Southern U.S.A. Not for use on Bermudagrass in Florida, Southern Alabama, Southern Mississippi, Louisiana, Southern Texas and California.

Not for use on winter overseeded Bermudagrass putting greens until seedlings are established. Not for use on Poa Annua where this turf is desired in the Southern part of the U.S.A.

Treat Bluegrass only in the fall through early spring and Bentgrass only in mid-fall through early winter In California, apply on Bluegrass and Bentgrass turf.

**SPREADER SETTINGS**

Rotary spreaders should be used with caution. Do not apply on a windy day or under conditions where material comes in contact with the operator.

**COOL SEASON GRASSES**

**BROWN PATCH, DOLLAR SPOT** Northern or Cool Season lawns such as bluegrass, bluegrass- fine fescue mixtures, Perennial Ryegrass and similar varieties (CA apply to Bluegrass varieties only.) Apply 1.6 - 2 lbs. per 1,000 sq. ft. to dry foliage at the first sign of disease. Repeat every 7 to 10 days during warm, damp weather.

**SNOW MOLD (Except CA, OR, WA)** on Bluegrass, Bluegrass blends with Fine Fescue or Perennial Ryegrass, Bentgrass or Bentgrass mixtures and similar varieties. Apply 4 to 6 lbs. prior to the first heavy snow. Use 6 lbs. per 1,000 sq. ft. in areas where snow cover is present the entire winter. On Bentgrass and on putting greens and tees containing Bentgrass, make one application in the mid-fall through early

winter.

**SNOW MOLD (CA, OR, WA)** on Bluegrass, Bluegrass blends with Fine Fescue or Perennial Ryegrass, Bentgrass or Bentgrass mixtures and similar varieties: Apply 4 to 6 lbs. per 1,000 sq. ft. to dry foliage through the winter months. Wait a minimum of 14 days between applications. Make one application in areas where snow cover is present the entire winter. On Bentgrass and on putting greens and tees containing Bentgrass, make one application in the mid-fall through early winter.

**STRIP SMUT (Except CA)** on Bluegrass and Perennial Ryegrass Apply 6 lbs. per 1,000 sq. ft. at first sign of disease. If the disease is still present, make a second application in 3-4 weeks. As a preventative treatment apply 6 lbs. in the fall and spring.

**STRIP SMUT (CA only)** on Bluegrass: Apply 6 lbs. per 1,000 sq. ft. at first sign of disease. If the disease is still present in 3-4 weeks, make a second application. Do not apply more than 3 applications per year. As a Preventative treatment apply 6 lbs. per 1,000 sq. ft. in the fall through early spring. Do not apply more than 3 applications per year.

**RUST** on Bluegrass and Perennial Ryegrass. Apply 6 lbs. per 1,000 sq. ft. at first sign of disease. If the disease is still present in 3-4 weeks, make a second application.

### **WARM SEASON GRASSES**

**BROWN PATCH, DOLLAR SPOT:** St. Augustine, Bermuda grass, Zoysia and similar varieties. Apply 6 lbs. per 1,000 sq. ft. to dry foliage in the fall as a preventative, or in the spring at the first sign of disease. Water the area to wash the granules to soil level. An additional application in 3 to 4 weeks may be needed if the disease is still present or if heavy rainfall or flooding occurs after the treatment.

**DICHONDRA:** Apply 6 lbs. per 1,000 sq. ft. to dry foliage and water lightly to insure movement to the soil level. Apply at first sign of disease. Repeat every 7 to 10 days during warm damp weather.

### **STORAGE AND DISPOSAL**

**PESTICIDE STORAGE:** Do not contaminate water, food or feed by storage and disposal.
