DANGER

FREMONT 2302 is a concentrated non-phosphate detergent, disinfectant, sanitizer, fungicide and deodorizer. It is designed for institutional use, such as hospitals, nursing homes, and schools, where housekeeping will be of prime importance in controlling the hazard of cross-infection.

FREMONT 2302 is for use on floors, walls and other hard surfaces in hotels and public areas, is excellent for operating rooms, rest rooms, nursery and food service areas. Effective in locker rooms, garbage pails, and sinks.

DANGER

Keep out of reach of children. Causes skin irritation. Causes eye damage. Protect eyes when handling concentrate.

Harmful if swallowed. Avoid contamination of food.

FIRST AID:

In case of contact immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash all contaminated clothing before reuse. If swallowed, do not induce vomiting. Drink large quantities of fluid and call a physician immediately.

DIRECTIONS

Use at 1 ounce per gallon of water. This product will be effective against Pseudomonas aeruginosa PRD - 10 at this level.

This has been substantiated by AOAC use Dilution Test. At this level, the product is fungicidal against Pathogenic Fungi. For best results, use FREMONT 2302 with a cloth or mop and apply to walls, floors and other hard surfaces.

If used for sanitization of food equipment or other food contact items, limit the level of active quaternaries to 200 ppm (1.4 oz. per 5 gallons). At this level a potable water rinse is NOT REQUIRED.

For heavy soil or organic matter, a pre-cleaning step is recommended.

Rinse empty container thoroughly with water and discard.

DIRECTIONS FOR USE

For use in Hospitals, Nursing Homes, Institutions, Offices, Schools, Motels and Hotels.

Kills Staphylococcus aureus, Salmonella choleraesuis and Pseudomonas aeruginosa.

For use on telephones, door knobs, night switches, bed springs, diaper pails, toilet seats, sink tops, bed pans, garbage pails, hampers, linen carts and desk tops.

To disinfect, hold can six (6) inches from surfaces and spray until completely wet.

To deodorize and air refreshen, point spray upwards to center of room and spray for three (3) seconds.

WARNING: Avoid getting spray concentrate in eyes. In case of contact, flush with water. If irritation persists, get medical attention.

WARNING: Flammable! Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposure to temperatures above 130°F. may cause bursting. Never throw container into fire or incinerator.
