To Kill Flies, Mosquitoes, Small Flying Moths and Gnats: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen. insects.

To Kill Cockroaches, Ants and Crickets: Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding.

To Kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

To Kill Carpet Beetles: Directly spray as many insects as possible. Spray both interior and exterior of uphoistered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. Repeat as necessary

To Kill Exposed Forms of Confused Flour Beetles, Saw-toothed Grain Beetles, and Rica Weevils: Find and destroy infested package goods. Remove all other items from paritry. Spray the shelves to kill any of the named insects present. Place clean paper on the shelves and return packages after shelves have dried. Repeat as recessary.

To Kill Sowbugs, Centipedes, Firebrats and Spiders: Contact as many insects as possible with the spray. Also thoroughly spray all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, crevices, hidden surfaces under sinks, behind stoves and refrigerators.

To Kill Fleas and Brown Dog Ticks: Remove and destroy old pet bedding. Spray sleeping quarters of pets, around baseboards, windows and door frames, wall cracks and local amas of floors. Repeat as necessary. Do not spray animals. Put fresh bedding in pets quarters after spray has dried. Also treat doos and cats with a registerer "ea and tick control product before allowing therit to entire treated area.

STORAGE AND DISPOSAL

Storage:

Store in a cool area away from hast or open flame.

Disposal:
