PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130 °F may cause container to burst. Do not apply this water-based product in conduits, motor housings, junction and switch boxes, or other electrical equipment because of possible shock hazards. Do not use on surfaces that may be damaged by water.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

READ ALL DIRECTIONS BEFORE USING THIS PRODUCT. SHAKE CONTAINER WELL BEFORE USE. HOLD CONTAINER UPRIGHT DURING USE.

FOR DOGS AND CATS: Spray the animal from a distance of 8-12 inches. Do not spray face, scrotum, or anus. Beginning at the tail, spray body and legs. Fluff the hair so the spray will penetrate to the skin. Make sure spray coats ticks thoroughly. Repeat as necessary.

For dogs, apply at the rate of two seconds per pound of body weight for thin or short-haired dogs and up to eight seconds per pound of body weight for heavy or long-haired dogs. For cats, apply at the rate of one second per pound of body weight.

FOR DOG HOUSES AND KENNELS: Remove pet's old bedding and either destroy or launder. Spray interior of dog house, sills, ledges, and outside runways. Put fresh bedding in pet's quarters after spray has dried.

STORAGE AND DISPOSAL

Storage:

Keep in locked storage area. Store in a cool dry place, away from heat, sparks, and open flame. Do not store at temperatures over 130 °F.

Disposal:

Do not reuse empty container. Replace cap and discard in accordance with all local, state, and federal laws and regulations. Reduce pollution at its source.
