The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

- For EPA Reg. No. 7056-162, add the following statements under the Directions for Use:

Do not use this unit in a cabinet or under a counter or table. Do not use this unit in an area less than 100 cubic feet.

Submit five copies of your final printed labeling before you release the product for shipment. A stamped copy of the labeling is enclosed for your records.

The alternate Confidential Statement of Formula (CSF) referred to above, submitted in connection with registration under Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is not acceptable. Please provide the chemical identity of all components, Material Safety Data Sheets, CAS Registry Numbers and the percentage or range in percentage in the mixture for the fragrance **Lemon Fragrance #295-7**. Please note that the certified limits but be the same for the basic and alternate formulations. Refer to the last accepted basic CSF and revise accordingly.

With regards to the CSF for EPA Reg. No. 7056-169, although the nominal concentration on the CSF agrees with the label claim, the CSF should be revised by splitting 0.050% for d-cis/trans Allethrin under column 13b as follows: d-cis/trans Allethrin 0.048% and Other Isomers 0.002%. The certified limits should be specified for each under column 14a and 14b.

HOLD CONTAINER UPRIGHT DURING USE.

TO KILL ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SOWBUGS, AND CARPET BEETLES: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing, and other utility installations. Pests driven out of hiding places should be sprayed directly. FOR ANTS: Also apply to ant trails, around doors and windows, and wherever these pests may find entrance. Repeat as necessary.

TO KILL BROWN DOG TICKS AND FLEAS: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames; and floor coverings where these pests may be present. Old bedding should be removed and laundered or replaced with clean, fresh bedding after treatment. Do Not Spray Pets With This Product. Repeat as necessary.

FLIES AND MOSQUITOES: Use only outdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window frames and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, on porch, patios, and in garages where these insects may congregate. Flies and mosquitoes landing on treated surface will be killed. Repeat as necessary.

STORAGE AND DISPOSAL

Storage: Keep in locked storage area. Store in a cool, dry place, away from heat, sparks, and open flames. Do not store at temperatures over 130°F.
Disposal: Do not reuse empty container. Replace cap and discard in accordance with all local, state, and federal laws and regulations. Reduce pollution at its source.
