HAZARDS TO HUMANS AND DOMESTIC ANIMALS

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Do not apply to water. Drift and runoff from treated sites may be hazardous to fish in adjacent waters

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130 °F may cause container to burst. Do not apply this waterbased product in conduits, motor housings, junction and switch boxes, or other electrical equipment because of possible shock hazards. Do not use on surfaces that may be damaged by water.

FIRST AID

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

READ ALL DIRECTIONS BEFORE USING THIS PRODUCT. SHAKE CONTAINER WELL BEFORE USE. HOLD CONTAINER UPRIGHT DURING USE.

TO KILL WASPS, HORNETS, YELLOW JACKETS, AND BEES: Foam sprays up to 22 feet. Application should be made in late evening when insects are at rest. Do not spray directly into the wind. Aim nozzle at nest and depress actuator until nest is encased in foam. This foam prevents wasps and other pests from flying away. Repeat as necessary.

TO KILL ANTS: Spray the foam on trails, nests, hills, and points of entry. Spray directly on ants where possible. Repeat as necessary.

TO KILL FIRE ANTS: Kills and temporarily reduces annoyance of these insects. To reduce annoyance from these ants and keep them from entering homes, spray the foam directly on patios, barbecue areas, driveways, door sills, window sills, other entrance areas, foundations of buildings, ant trails, around pools, and areas where the ants are noticed. This treatment will not kill the colonies, but will reduce the immediate population for up to four hours. Repeat as necessary.

Test whether spray may discolor or otherwise damage materials on which it is applied by spraying a small, inconspicuous area until wet. Allow area to completely dry and check for discoloration or damage. Do not continue to use if materials are adversely affected.

TO KILL SPIDERS: (including Black Widow and Brown Recluse) Spray the foam in short bursts directly on spiders. Repeat as necessary.

TO CONTROL NUISANCE PESTS: COCKROACHES, CRICKETS, SILVERFISH, EARWIGS, SOWBUGS, CENTIPEDES, AND MILLIPEDES: Spray the foam directly on areas infested with these nuisance pests. Repeat as necessary.
