### DIRECTIONS FOR USE

Dilute with oil as follows:

FOR FOGGING: 1 part Guardian Pyrethrin No. 6601 to 9 parts of oil.


TO KILL FLIES. MOSQUITOES AND GNATS: Close doors and windows, directing the spray up toward the ceiling. The room should be tilled with mist and remain closed for 10 to 20 minutes. Sweep up dead insects and burn. Repeat treatment as necessary. The frequent spraying of breeding places also hely DO NOT REMAIN IN TREATED AREAS. VENTI-L. TE THE AREA AFTER TREATMENT IS COMPLETED.

TO KILL ROACHES, WATERBUGS AND SILVERFISH: Spray libera'ly with force around refrigerators, sinks, all cabinets, around pantry shelves, into all cracks and crevices in moulding and woodwork, pipe opening in walls and floors, or wherever these insects might hide. Repeat as necessary.

TO KILL ANTS: Use the spray so as to wet as many insects as possible, paying particular attention to nests or runways. Repeate as necessary.

TO KIL'. BEDBUGS: Bedsteads should be sprayed thoroughly in all corners, cracks and crevices. Springs and mattresses should be sprayed thoroughly after the bed has been dismantled, spraying tufts and seams in the mattress, Spraying loose mouldings, cracks and crevices where insects hide.

TO KILL CLOTHES MOTH AND CARPET BEETLES: Special care should be given to be sure all cracks and openings below the baseboards are thoroughly wetted with spray. Clothes when aired, should be sprayed at a distance of 2 to 4 feet. taking care to see that seams and folds are wetted. Garments should be treated every 30 days if not put in moth tight storage after treatment.
