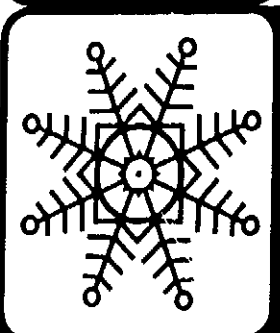
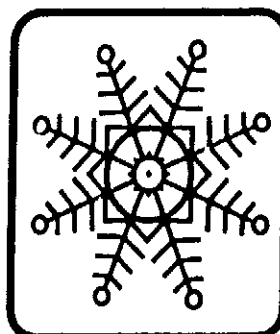
INGESTION: Give two glasses milk of magnesia, milk or water. Call physician, gastric lavage may be indicated.

STORAGE AND DISPOSAL

DIRECTIONS FOR USE:

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Do not mix Winterizing Powder with any other chemicals as dangerous reaction may occur.

Add Winterizing Powder to a clean, algae free pool. For best results vacuum or remove by hand any debris and super chlorinate pool prior to introducing this product. Use at the rate of 16 ounces (1 lb.) for every 10,000 gallons to be treated. Predissolve 1 lb. of Winterizing Powder in a bucket containing at least 2 gallons of water.

Stir until all particles are dissolved, pouring off liquid and diluting any remaining solids with additional water if necessary. Pour solution into the skimmer making sure that pump is on, skimmer contains no other material and water is flowing freely into skimmer. Allow filter to run for several hours for good distribution. If filtration system has been dismantled, pour solution into pool while walking around the perimeter. Distribute solution as widely as possible. Cover pool after winterizing has been completed.
